Description:

3M™ Neutral Floor Cleaner is specially designed to clean any washable hard floor. It can also be used as a restorer for use prior to buffing or burnishing. It cleans floors as well as restores gloss and luster to floor finishes.

Special Features:

- Maintains high gloss on floor finish
- · No rinsing required
- Low sudsing, neutral formulation will not harm floors or leave a soapy residue
- Excellent cleaner designed for regular use

Applications:

- Use on washable hard floor surfaces
- Use in your regular floor maintenance program to keep your floors clean
- Use in your buffing or burnishing program to help restore gloss and luster to your floor finish

Packaging:

Concentrate:

4 – 1 gallon bottles per case
2 – 2.5 gallon bottles per case
55 gallon steel drum

Note: Protect from freezing and keep away from heat and sparks.

General Use Directions:

3M[™] Neutral Floor Cleaner can be used when manually cleaning with a damp mop or when using an automatic scrubber. You can spray buff immediately after cleaning, with no rinse required. It can also be used as a restorer, prior to buffing or burnishing.

Dilution of Concentrate:

Mix 1 part concentrate with 64 parts cool water / 2 ounces per gallon of water

Product Use Instructions:

To clean soiled floors:

- 1. Sweep or dust mop floor.
- 2. Damp mop floor with diluted cleaner.
- 3. Allow floor to dry. No rinsing is required.

To clean heavily soiled floors:

- 1. Sweep or dust mop floor.
- Mop floors with diluted solution and scrub as required using a floor machine and an appropriate 3M floor pad.
- 3. Damp mop with diluted cleaner.
- 4. Allow floor to dry.

To use as a restorer:

- 1. Follow above directions (soiled) floors.
- 2. Buff or burnish floors with appropriate 3M floor pad.
